DIRECTORS' REPORT

The Directors submit their report and accounts for the year ended 31 March 2022.

Structure, Governance and Management

The Enterprise Company is a company limited by guarantee and is governed by its Memorandum and Articles of Association.

The Directors are recruited by seeking appropriately experienced volunteers amongst the membership. Directors have to be formally approved at the next annual general meeting following their appointment.

The management of the Enterprise Company is carried out entirely by the Directors.

Objectives and Activities

The principle aim of the enterprise company is to promote the benefits of the inhabitants of the Drymen area by associating with the local statutory authorities, voluntary organisations and inhabitants in a common effort to facilitate sustainable development for the community so that the conditions of life may be improved. Delivery of aspects of the Community Action Plan form a key focus for the Trust activities as well as reacting to new opportunities and challenges as they appear.

Achievements and performance

A very active and committed DCDT team have had a busy and productive year, with the prime focus being the renewal of the Drymen Square area, which is owned by the community and managed on its behalf by the Trust.

Several funding partners awarded grants that enabled the Trust to oversee a variety of projects, all under the banner of 'Discover Drymen', developing a series of assets and improvements for the benefit of residents, businesses, and visitors to the village. They are:

- A new village website drymen.org
- Renewal of section of parking bays on Square (by butcher/library)
- Drymen Heritage Trail (in association with Drymen Heritage), with map and guide, and accompanying audio podcasts recorded by residents.
- Renewal of bus shelter, including installing solar panels on its roof to power lighting inside and an ebike charging station. There is also a new bike maintenance station and (coming soon) a mural inside the shelter promoting the start of the Rob Roy Way/NCN7.
- Five Information Panels, courtesy of RSPB Scotland, specific in content about Drymen and the nearby reserve will be installed in the tunnel area by the hotel.

Further to these achievements, we successfully applied to Scottish Water to introduce a top-up tap at the Square. Together with DCC, we asked Stirling Council to install a new pavement alongside the Square to improve safety for pedestrians. The council agreed to our request and to resurface the existing paved area next to the new pavement.

DCDT has supported Forth Environment Link's 20-minute Neighbourhood Study, providing practical help, local knowledge, and support for their innovative programme of community consultations. The outcome of this valuable study, along with further public meetings, will help DCDT and DCC to create a 10-year Place Plan for the village.

In addition, the Trust, along with other stakeholders, is represented in the East Loch Lomond Visitor Management Group. Loch Lomond & The Trossachs National Park set this group up in response to challenges faced by communities during and after Covid. As part of that, we are inputting to work by consultants to achieve £3.5m of new and improved infrastructure for East Loch Lomond designed to help address issues caused by rising visitor numbers.

DCDT, working closely with DCC, is trying to find a solution to the lack of public toilets in the village, which is a significant issue. We are appealing to stakeholders that this is a key priority.

This year we are working hard to deliver some key outcomes of the recent Active Travel Survey which received tremendous support from the community. We now have five qualified bike leaders who provide guided cycle rides. In addition, many residents have benefitted from free e-bike trials and from a recent 'Doctor Bike' event, where bikes were checked and fixed by an expert. As a result of these and other actions, Cycling Scotland has awarded the village silver status for the first time.

DCDT are committed to improving walking and cycling within and from/to the village. Strong, active travel credentials help deliver funding for improvements and enhancements, which benefits everyone.

A tree was planted in the grounds of the doctor's surgery, honouring Kenneth Cameron who left a legacy to the Trust. The tree was dedicated to the NHS and village Covid 19 support group in the village, whose actions provided tremendous support to the community during the pandemic.

The Trust was pleased to bring back Piping on the Square in the summer and organise Drymen Advent Windows and Christmas Tree Light Switch-On. In addition, the recent spring litter pick was well attended.

Membership of DCDT has grown a little from last year's record high. We continue to engage with the community as much as possible with regular newsletters, website updates, Facebook posts, articles in each edition of the Drymen Reporter and an annual village-wide leaflet of key priorities. We hope that we will once again be able to host member events and meetings.

Building on a few years of the phased delivery of Square renewal, DCDT remains committed to finding a solution for resurfacing the road around the Square. Other key priorities are seeking the introduction of public toilets and producing a Community Place Plan for the next decade.

I would like to thank all DCDT volunteer directors, members, funders, and supporters for helping deliver significant improvements to the Village Square area during the last 12 months.

Financial review

The 2021/22 financial year has been very positive for the Trust the membership has continued to rise over the year with the membership numbers standing at 146, and with a move to reminding members to renew on a rolling basis we have spread the workload for managing the membership. Over the course of the financial year we have received circa £50k in grant funding which has supported all of the activities mentioned above. We have also received Support from connecting Scotland who now provide the Mifi connections for the digital inclusion project until Dec 2023.

With the return of Piping in the Square, a good membership and gift aid we have had a good non-grant income of £2,078

Our main Expenses through the year have been:

- 1. The repairs to the Parking bays in May 2021 (£20,431 at completion)
- 2. The Renovations to the Bus shelter, which is nearing completion (£21,835)
- 3. The Historical Trail, also nearing completion (£1,452)
- 4. The Website Project (£1,567) completed June 2021
- 5. The Installation of Bike Stands in the Square (£1,545)

Over the course of the year we have seen increases in both the Restricted and Unrestricted funds, due to the grant funding received, piping in the Square and the good membership numbers, however it is worth noting at this point that due to market conditions during 2021 the bus shelter project is expected to over spend by about £3,000 which will have a significant impact on our unrestricted funds in the next accounting period. It is also worth noting that in the course of the completing the Bus shelter project, a payment was made to a hacker when dealing with one of the suppliers, this was resolved as the hack was into the supplier email system and they accepted responsibility and honoured the agreement, supplying the equipment.

The Trust is very grateful to all of the organisations which have provided funding this year, without which the Trust could not carry out its activities.

Directors and their interests

The Directors who served during the year, are shown on page 2.

During the Period "Think Topping" was paid £950 to carry out the preparation of Audio Files for the Heritage trail. Katy Gibb is a director of both the Trust and Think Topping.

1. Status

The Company is limited by guarantee and does not have a share capital. The Registrar of Companies has authorised the Company to dispense with the word "Limited". The Company is not liable to taxation because of its charitable status.

2. Accounting policies

- (a) The accounts are prepared in accordance with FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland', including the Statement of Recommended Practice for charity accounts, and under the historical cost convention, on a going concern basis.
- (b) Donations and grants are included in the financial period of receipt.
- (c) Grants relating to a specific project are treated as restricted.
- (d) The cost of the heritable land owned by the company is not depreciated.

Fixed assets

The company owns the heritable land in Drymen known as The Square.

Some of the funds carried forward into 2021/22 for the path works ('Connecting Communities') project will be used to pay for outstanding commitments. The remainder (almost £30,000) will be available for completion of the path into Balmaha, and the Trust is in discussions with the National Park Authority about the most appropriate means to achieve that. The donations for the paths leaflet will be used to fund a future reprint when supplies are exhausted. The Play Park project has almost been completed in this financial year. The Play Park team are in discussion as to how the remaining funds should be spent. The Digital inclusion project is a Covid Team project in response to the library closing this project has been extended until Dec 2023 with provision of MiFi from Connecting Scotland. Drymen.org website is a community web site project to deliver a community web site for Drymen, this was delivered for the 2021 AGM and the remaining funds will be used to cover ongoing costs of the website. The current phase of the historic walk project is almost complete and will go live shortly, this will provide Leaflets, Signage and audio for a historical tour of Drymen. The Bus Shelter Renovation / Green Cycle hub the renovation of the Bus shelter with a new solar roof, E-bike charger and Bike Maintenance. The Lead cycles Project is providing lead cycles to encourage active travel around Drymen.

Designated property fund

Funds equal to the cost of The Square are treated as a designated fund.
